Why does the market for one particular good deserve its own class? Because the labor market is so important! It's how we earn our livelihoods. Practically everyone will participate in the labor market as a seller, and some will participate as a buyer as well. (Even if someone does not participate in the labor market, we can analyze that choice using the tools of labor economics.) Firms spend more on labor than on other inputs, and the labor market is also an important area of government policy.

I enjoy this class because we get to move beyond the simple microeconomic models and discuss some more complicated models. You will find this class more "real-world" than Econ 291. I hope that you will enjoy it too.

#### Goals for this Class

- 1. Learn how labor markets work. Develop an appreciation for the complexity of real-world markets.
- 2. Developed informed opinions about labor market policy.
- 3. Practice and develop skills in microeconomic theory.
- 4. Practice and develop skills in data analysis and econometrics. Develop Stata skills.

#### **Tools**

This is an upper-level economics class. We will use theory introduced in Econ 291, and econometrics introduced in Econ 253, to study the labor market. Both are prerequisites.

#### Exams

I will ask you to turn in a brief summary of each paper we read. Your summary should identify the question asked, the author's conclusion, and the evidence presented to support that conclusion. Late homework will receive half credit. No homework will be accepted after the last day of class.

We will use data extensively in this class; the computer labs will require you to download and analyze data. Always turn in both your data file and either your log or do file with your answers. I will take off points if I cannot find these files.
